Level 1 | **\$2,500*** (Less than 1,000 Texas employees) **Level 2** | **\$5,000** (1,000 or more Texas employees)

Associate Members receive one vote on issues before the general membership. Associate Members may also serve on the Executive Committee in an at-large position and are eligible to hold a committee leadership position.
